PURPOSE OF THE DATA PROCESS

METHOD OF DATA PROCESSING AND RETENTION PERIOD

The processing of data is done by manual, computerized and telematic tools with logic strictly related to the purposes mentioned above and, in any case, in such a manner to guarantee the security and confidentiality of the data.

Your Personal Data will not be kept in a form that allows you to be identified for any longer than is reasonably considered necessary by Dab for achieving the purposes for which it was collected or processed or as it is established in the applicable laws related to data retention periods.

NATURE OF DATA SUPPLY

Dab will not store, transfer or in any other way process your Personal Data outside of the specific purposes mentioned above.

- (ii) to request correction, supplementation or deletion of Personal Data about you that is inaccurate or processed in non-compliance with applicable requirements, and
- (iii) to request us to restrict the collection, processing or use of Personal Data about you, and
- (iv) in certain circumstances, to object for legitimate reasons to the processing of your Personal Data, and
- (v) to request data portability.
